## Terms and conditions of Visa's campaign for driving [International Spend & Win] on Visa cards

Introduction: This document outlines the terms and conditions ("Terms") of the Visa Worldwide Pte. Ltd.'s ("Visa") 'International Spend and Win' campaign ("Campaign") to promote international spends on Visa cards by Cardholders (as defined below). The Campaign is offered by Visa to all holders of a valid and active Visa consumer debit card, Visa consumer credit card and/ or Visa consumer forex prepaid card ("Eligible Card") issued by licensed issuers in India ("Cardholder", "you", "your"). The Campaign shall be valid for the Campaign Period (as defined below) subject to availability of stock. For avoidance of doubt, no Visa domestic prepaid card, or Visa commercial, business or corporate card shall fall within the definition of Eligible Card and be eligible for any benefits under the Campaign. For avoidance of doubt, Forex prepaid cards that carry the word "Corporate" on the card are not consumer forex prepaid cards and are not eligible for this offer.

## 1. Eligibility:

- To participate in the Campaign, you must be an existing Cardholder of an Eligible Card or obtain a new Eligible Card ("New Eligible Card") issued by any of the licensed issuers of Eligible Cards ("Issuers") and perform the following:
  - Spend at least \$1000 (United States Dollars one thousand) or an equivalent amount in foreign currency, which is equal to or exceeding INR 85,000 (Indian Rupees Eighty Five Thousand) (whichever is higher) ("Eligible Spend") either online at an international merchant in a non INR currency or physically at a merchant Point of Sale (POS) outside India (International Merchant) or cash withdrawals at an ATM outside the geography of India during the Campaign Period between October 15, 2025 to February 15, 2026.
- All transactions on an Eligible Card should have been processed on VisaNet in order to be considered as part of the Eligible Spend.
- A Cardholder will qualify for the Campaign only if the payment transaction value on an Eligible Card or a New Eligible Card for products and services that are not cancelled or returned during the Campaign Period meets the Eligible Spend criteria mentioned above.
- 2. **Campaign Period**: The Campaign will run from October 15, 2025 till February 15, 2026 (inclusive of both dates), or till such date the stocks last, whichever is earlier ("**Campaign Period**").

### Voucher:

- Each Cardholder fulfilling the Eligible Spend criteria for the Campaign will win a Voucher of INR 1000 (Indian Rupees Eighty Five Thousand) for availing discounts on Amazon ("Voucher").
- Vouchers are non-exchangeable, and non-refundable. No cash alternative or substitute to the Vouchers will be provided. The validity of a Voucher will start from the date of the code made available to a Cardholder redeeming the Voucher as provided below.
- Cardholder of one Eligible card is entitled to receive a maximum of one Amazon Voucher of Rs. 1000 in this campaign.

# 4. Redemption and Use of Vouchers:

- Eligible Cardholders can redeem their Voucher by logging into the website <u>www.visarewards.poshvine.com</u> ("Website").
- On the Website, eligible Cardholders will have to enter the 16-digit card number, CVV, card expiry date of the Eligible Card and mobile number.
- An OTP will be sent to the registered mobile number of the eligible Cardholder, which will have to be entered for verification.
- Once the Cardholder is successfully authenticated, the Voucher will be displayed. The 'Know more' widget will provide the offer details and offer terms and conditions.
- A unique 13-character Amazon Shopping Voucher code will be displayed for the Voucher that a Cardholder has claimed and will also be sent on the mobile phone of the Cardholder.
- o This code can be used on the Amazon website (<u>www.amazon.in/vouchers</u>) to redeem the Voucher.

- In case of any issues or queries regarding the redemption process or the redemption website, an eligible Cardholder can write to the customer care team at visaoffersupport@razorpay.com, managed by RazorPay International Services Pte. Ltd.
- A Voucher can only be claimed after 7 (seven) days from the date of completing the last of the transactions on the Eligible Card that qualifies the Cardholder for the Voucher, but no later than 97 (ninety-seven) days from the aforesaid date.   - The Voucher code can be redeemed only on Amazon.in by adding it to the Cardholder's Amazon Shopping Voucher Balance.
  - Each Voucher can be used only once, and the full value will be credited to the Cardholder's Amazon Shopping Voucher Balance upon redemption.
  - If the amount of the purchase is less than the Voucher denomination, the remaining value will stay in the Amazon Shopping Voucher Balance for future use in accordance with Amazon's policies.
  - If the purchase amount exceeds the Voucher value, the balance payment shall be made using any other valid payment method accepted on Amazon.in.
  - The Voucher cannot be used for recharges, bill payments, subscriptions (including Amazon Prime, Kindle, Audible, etc.), purchase of gold, jewellery, or any other restricted categories as per Amazon's policy.

  - The Voucher must be used within 90 (ninety) days from the date of receiving the Voucher code by the Cardholder. Post expiry, the Voucher will no longer be valid and cannot be reissued.

- Accept that Visa reserves the right to modify, suspend, cancel, or terminate the Campaign and these Terms or any part of it without prior notice or reason.
- Accept that Visa has the sole and final discretion to determine the winners and the Vouchers, and that their decisions are final and binding.
- O All taxes, fees, and surcharges on Vouchers are the sole responsibility of the Cardholder.
- Visa reserves the right to disqualify any Cardholder who tampers with the entry process or does not qualify in accordance with these Terms or in any manners subvert or tries to subvert the objective of this Campaign.
- Visa is not responsible for any technical failures that may prevent an individual from participating in the Campaign.
